Terms & Conditions for Volunteers

Age Specifications

Volunteers are required to be 16 years old and above.

Under special circumstances children below the age of 16 years may volunteer on condition that they do so under parental / adult supervision.

Indemnity

All volunteers must sign an indemnity for as per Annexure A.

Criminal Conviction

Should the Manager of The Open Door Crisis Care Centre discover that a volunteer failed to disclose a criminal conviction, such volunteer can be asked to submit an explanation in writing and the Manager shall make a decision as to whether it is in the best interests of the organization that such a volunteer continue his / her service or whether such service should be terminated. Any termination under this section shall be done in writing and placed on that volunteers file.

Dress Code

Volunteers, whilst performing duties for The Open Door Crisis Care Centre should be presentable and neat. Where volunteer T-Shirts have been provided, these should be worn.

Behavior

No volunteer may have contact with the media regarding any matter that The Open Door Crisis Care Centre is dealing with or involved in without the permission of the Director.

Any volunteer who is found to be dishonest, commits any act of insubordination; committing a crime, or acts in any manner which is not in the best interests of the organization, shall at the discretion of the Director, be dismissed as a volunteer of the Open Door Crisis Care Centre.

Volunteers are representatives of The Open Door Crisis Care Centre and shall at all times act in a professional manner, treating fellow volunteers; staff and members of the public with respect.

Acceptance

Once a volunteer has been accepted, he / she will be notified.
